## Section 6. Accidental release measures

**Personal precautions, protective equipment and emergency procedures**

#### **Methods and materials for containment and cleaning up**

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). ## **Section 7. Handling and storage**

#### **Precautions for safe handling**
